The ERPW 2018 was hosted by the Croatian Institute for Medical Research and Occupational Health (IMROH) gathered more than 250 participants from 34 different countries, with 93 oral presentations and 37 posters.

The program allowed numerous opportunities of discussion between the participants, the different European Platforms, and researchers worldwide.

Students had the opportunity to present their ideas during a Young scientist dedicated session and it motivated experienced researchers to question or advice for the extension of research.

CONFIDENCE

By December 2018, CONFIDENCE is running now 2 years and has progressed as foreseen in the initial work plan. Following a detailed investigation about uncertainty drivers in the early phase mainly related to source term estimation and atmospheric dispersion and deposition, a first test scenario for the NPP Borssele was successfully completed. Here ensemble source terms and ensemble meteorological conditions were applied. Results will be discussed in the stakeholder panels of 2019. Uncertainties in monitoring were explored and a health risk model was developed. The applicability of that model will be further discussed with relevant stakeholders. The uncertainty study of the foodchain model FDMT was completed and key parameters identified. This will help in discussing possible improvements by process-based models that are under investigation at present. Experimental work on iodine was completed.



Many national panels on countermeasure strategies discussing among others the role of uncertainties in the decision making process have been performed and a summary report on the findings is under preparation. A Delphi study is still ongoing to collect information about stakeholder involvement and decision-making in Europe. Case studies and observation of emergency exercises are in progress. Survey data in Belgium, Spain and Norway have been collected to investigate the response of the population to requests from authorities. A second prototype of the multi-criteria decision aiding software that includes uncertainty processing of model results and of preferences of decision makers became available for distribution. At present, work on the improvement of the negotiation process in the agent based modelling system aiming to understand better the decision process, is ongoing.

Finally first training workshops were prepared and the first will be conducted in May 2019 in Trnava, Slovak Republic.




TERRITORIES

On 12th of December 2018, the first “stakeholders panel” of TERRITORIES WP3 was organized in Bordeaux (France), by two TERRITORIES partners ([IRSN and CEPN](#)), and the [local commission \(CLIN\) of Le Blayais Nuclear Power Plant](#).

This panel of local stakeholders, looked into the medium- and long-term challenges after an hypothetical accident, and the socio-economic uncertainties facing these stakeholders, in light of their local knowledge.

On the day before, on 11th of December, a seminar had enabled actors in the Bordeaux region to talk to their counterparts from Japan and Belarus involved in the long-term rehabilitation after the Fukushima-Daiichi and Chernobyl accidents. The reports mainly related to the difficulties and challenges for agriculture in how it deals with the long-term consequences of the post-accident situation. They presented their experiences of the remedial measures taken in the sector and the conditions and difficulties with regard to the resumption of agricultural activities after an accident.

SHAMISEN-SINGS

A workshop on "Preparedness to Nuclear and Radiological emergencies: Keys to improve it" with participation of Spanish stakeholders was organised by SEPR (Spanish Society of Radiological Protection), in collaboration with ISGlobal, UPM and CIEMAT in Madrid. The workshop took place on 21st September and was hosted by UPM.

About 40 participants, representing a wide spectrum of organizations and stakeholders, including authorities (CSN – Nuclear Safety Council), participated in the Workshop with the goal of identifying strengths and limitations in the preparation of emergency response and post-accident recovery in Spain. They gathered together to work jointly on the questions of emergency preparedness, sharing their own opinion, visions and experiences. Past and current European projects were presented: EURANOS; NERIS-TP; PREPARE; SHAMISEN; CONFIDENCE, SHAMISEN SINGS and ENGAGE.

The Workshop was a success and received a positive feedback from all participants who worked in groups to extract useful conclusions. Results are in preparation and will be soon published in the SEPR journal (in Spanish) and later in the European community (in English).


